### **Pharmacy Formulary Tier Exception**

VIVA MEDICARE reviews exceptions to its tiered cost-sharing structure and formulary requirements as part of its coverage determination review process. VIVA MEDICARE has implemented the following as guidelines for these reviews. In this review process, the pharmacist must determine when the member has experienced an inadequate treatment response, intolerance, or contraindication for a formulary or tiering exception to be approved.

There may be certain clinical scenarios that warrant a decision outside of these guidelines, but we feel this maximizes formulary utilization and aids our providers in having available options to effectively treat our members.

#### **VIVA MEDICARE Tried/Failed Medication Review Guidelines for Formulary and Tier Exceptions**

If there are **1-2** formulary alternatives, then the patient must have tried/failed at least **1** of these

If there are **3-4** formulary alternatives, then the patient must have tried/failed at least **2** of these

If there are **5-6** formulary alternatives, then the patient must have tried/failed at least **3** of these

If there are **7-8** formulary alternatives, then the patient must have tried/failed at least **4** of these

## What's the difference between Medicare's Open Enrollment Period (OEP) and Medicare's 5-Star Special Enrollment Period?

The Medicare Advantage Open Enrollment Period (MA OEP) is available from **January 1 to March 31.** Beneficiaries who are enrolled in a Medicare Advantage plan as of January 1 can make a one-time change to go to another Medicare Advantage plan or Original Medicare (and make a coordinating change to add or drop Part D prescription drug coverage).

The Medicare 5-Star Special Enrollment Period is available from **December 8, 2023 to November 30, 2024.**Medicare beneficiaries can use the 5-Star Special Enrollment Period to switch from their current Medicare plan to a Medicare plan with a 5-Star Rating, like VIVA MEDICARE. This special enrollment period can be used only once. For plan year 2024, it can be used **anytime of the year** until November 30, 2024.

#### Provider Portal Account Management

VIVA HEALTH recommends that users create a "strong" password in the Provider Portal. The following password guidelines can help protect your office, your patients and our organization:

- Passwords should be at least 8 characters in length.
- Use different passwords for all accounts/applications.
- Never share your password or login with anyone (each user must have a unique login).

Remember, you are responsible for what happens under your login in the Provider Portal. It is the responsibility of the Provider Portal Administrator to regularly review the list of users for the practice/facility to ensure access is appropriate. Access must be disabled immediately when a user's access is no longer required.

Provider Portal Administrators are also responsible for provisioning and managing accounts of any third party not employed or contracted by your practice (i.e., third party billers, TPAs, etc).

# CMS Expectations Regarding *Insulin Coverage*Under Medicare Part B or D

- Part B Coverage: Insulins delivered by a non-disposable insulin pump (e.g. Medtronic, Tandem) process under Medicare Part B benefits. Non-disposable pumps deliver insulin through tubing.
- When requesting coverage for a patient's non-disposable insulin pump under Part B benefits, please also include the following information with the request:
  - The name of the insulin used in the pump and date of first use of the insulin in the pump.
- Where the patient intends to fill the insulin (DME supplier or retail pharmacy).
- HCPCS codes and Diagnosis codes
- Ordering MD's NPI number
- Part D Coverage: Insulins delivered in a disposable (tubeless) insulin pump (e.g. Omnipod, V-Go) process under Medicare Part D benefits.
  - A covered insulin includes those listed on the Part D formulary, approved through a formulary exception, or paid through a transition fill.
- Insulins that are covered under Medicare Part B or D will have a maximum copay of up to \$35 for a 30 day supply, \$70 for a 60 day supply, or \$105 for a 90 day supply.



### **SNP MOC Training**

The Centers for Medicare & Medicaid Services (CMS) requires that Medicare Advantage Organizations provide Special Needs Plan (SNP) Model of Care (MOC) training to all participating Medicare providers that care for Medicare/Medicaid dual eligible members.
